SPECIAL TERMS (please review carefully):

Any questions regarding these specifications or work to be performed shall be directed to **Marcus Smiley**, Decatur Beautification, by calling **(256) 341-4733**, or emailing your questions to **msmiley@decatur-al.gov.**

- A. The Contractor will be responsible for all work performed, any repairs to equipment and any damages caused to City property or a citizen's personal property/vehicles; this includes, but is not limited to: broken car windows, broken windows at a place of business, any slung rock related accidents, any accidents caused by the tractors or mowing equipment and accidentally mowing over items that aren't supposed to be cut. These incidents shall also be reported to Beautification Department.
- B. Equipment will comply with all safety regulations while mowing (such as flashing lights, reflector signs, etc.) The contractor is responsible for establishing mowing zones, signs, etc. in place, where mowing is to be performed. Contractor is responsible for ensuring that roadways are clear of excessive cut grass/debris within 24 hours of mowing. Contractor shall perform their work in a manner that the traveling public safety is not compromised. Contractor's proposal to use subcontractors shall be presented to the project manager and approved before proceeding with such agreements.
- C. The Beautification Department will approve mowing/cutting prior to each start. Contractor will notify the City representative (Marcus Smiley) each Monday by 9:00am of areas that were completed the previous week, as well as areas planned to be completed in the week ahead. In the event that excessive rain occurs or some other natural event occurs that keeps this work from being performed, the Contractor must report this delay to the Beautification Department and work must be re-scheduled immediately after the natural event has ended or within a reasonable amount of time has passed to resume mowing/cutting. Area's that cause "rutting" from equipment are considered too wet to mow.
- D. If any areas cannot be mowed due to non-weather reasons, such as large obstacles (examples-large piles of rocks, limbs, debris, etc. that need to be removed or aren't typically a part of the natural landscape) or damage to terrain (examples-steep slopes that may cause erosion or rutting if the proper equipment is not utilized), these items should be reported to the Beautification Department. Small obstacles in the way of mowing (Examples-a bag of trash, a tree limb, or a visible rock that could be ejected from the mower deck) shall be removed by Contractor to continue mowing/cutting.
- E. Weeds around utility boxes, fire hydrants, power poles, signs and street signs need to be maintained. Mow fields around Decatur Utilities. Weeds around manholes in fields and ditches will be maintained, trim weeds back over ditch banks, and trim bushes and weeds around headwalls and culverts.
- F. If a City of Decatur crew has to perform work or complete a job designated for contractors, cost for the work will be deducted from the monthly invoice. Cost deducted will reflect the cost originally bid.

- G. Contractor will be notified in writing of any work that is deemed unacceptable and shall have 72 hours to remedy the deficiencies. In the event that Contractor fails to do so, the City will have the right to terminate the contract, cease all payments to Contractor, and contract with the next low bidder.
- H. Every attempt by the City to remove litter before mowing will be in effect. However, any litter found by the contractor must be picked up and disposed of properly before area is completed.
- Contractors will only use vehicles that properly identify the name of the company that they represent.
 Contractors must use appropriate PPE when performing work throughout the City of Decatur.
 Contractor's employees will wear appropriate clothing, name tag, or other clothing to identify their company at all times while working.
- J. Contractor's management will meet with City Mangers or Supervisors at least monthly to perform a work-through for specific or detailed areas in order to review service quality and performance. Contractor's management shall email daily, before 8am, the proposed work to be completed for the day.

AWARD:

- A. Bidder may submit prices for one or more line items listed on the "Price Sheet".
- B. Bid award will be based on individual line items, or total bid, whichever is deemed to be in the best interest of The City.
- C. Proposals will be considered only from those contractors who regularly perform the type of services described in the scope of work and who are financially responsible and have the necessary equipment and facilities required by this proposal to provide said services and to meet the standards as stipulated in these documents.
- D. The City of Decatur may request information substantiating the above requirements. Failure to provide such information may result in the bid being considered non-responsive. It is understood that the right is reserved by the City of Decatur to thoroughly inspect and investigate the establishment, facilities, equipment, business reputation, and other general qualifications of any contractor and to reject any bid irrespective of bid prices, if it shall be administratively determined.

CONTRACT TERM:

The term of this agreement will commence from the date the council awards this contract, for a period of 1 year, with the option to renew for 2 additional 1-year periods, provided the terms of the contract do not materially change.

INSURANCE REQUIREMENTS:

The Contractor will be responsible for any damage caused by the contractor, its employees, or equipment while engaged in this contract. Right-of-Way mowing includes all Right-of-Ways, Holding or Retention Ponds & Ditches listed at the locations below. These locations need to be cut twice per month during peak growing season (June, July, and August). This equals to 6 mows in a calendar year with the exception of Hwy 67/Beltline Road from Lynn Layton around to Hwy 20 and Hwy 31 from Lynn Layton to Flint Big A-these will require a weekly cut unless specified otherwise by the City Contract Representative. Section 34-8-1

Definitions.

- (a) For the purpose of this chapter, a "general contractor" is defined to be one who, for a fixed price, commission, fee, or wage undertakes to construct or superintend or engage in the construction, alteration, maintenance, repair, rehabilitation, remediation, reclamation, or demolition of any building, highway, sewer, structure, site work, grading, paving or project or any improvement in the State of Alabama where the cost of the undertaking is fifty thousand dollars (\$50,000) or more, shall be deemed and held to have engaged in the business of general contracting in the State of Alabama.
- (b) For the purpose of this chapter, a "general contractor" is defined to include one who, for a fixed price, commission, fee, or wage exceeding five thousand dollars (\$5,000), undertakes to construct, superintend the construction of, repair, or renovate, any swimming pool, and anyone who shall engage in the construction, superintending of the construction, repair, or renovation of any swimming pool in the State of Alabama, where the cost of the undertaking exceeds five thousand dollars (\$5,000), shall be deemed and held to have engaged in the business of general contracting in the State of Alabama and shall be subject to this chapter.
- (c) For the purpose of this chapter a "subcontractor" is defined to be one who constructs, superintends, or engages in the construction, alteration, maintenance, repair, rehabilitation, remediation, reclamation, or demolition of any building, highway, sewer, structure, site work, grading, paving, or project or any improvement in the State of Alabama where the cost of the undertaking is fifty thousand dollars (\$50,000) or more under contract to general contractor as defined in subsection (a) or another subcontractor.

Section 34-8-8

Copy of chapter to be included in plans of owners, architects, and engineers; inclusion of license number on bid.

- (a) All owners, architects, engineers, construction managers, and private awarding authorities preparing plans and specifications for work to be contracted in Alabama pursuant to this chapter shall include in their invitations to bidders, including but not limited to all public and private advertisements, and their specifications a copy of the portions of this chapter as are deemed necessary to convey to the invited bidder, whether he or she is a resident or nonresident of this state and whether a license has been issued to him or her or not, the information that it will be necessary for him or her to show evidence of license before his or her bid is considered. Any person including an owner, architect, engineer, construction manager, or private awarding authority who violates this section shall be guilty of a Class B misdemeanor and shall for each offense of which he or she is convicted be punished, fined, or both, in accordance with Sections 13A-5-7 and 13A-5-12.
- (b) All owners, architects, engineers, construction manager, or private awarding authority receiving bids pursuant to this chapter shall require the person, firm, or corporation to include his or her current license number on the bid. The owner, architect, engineer, construction manager, or private awarding authority shall reject all bids that do not contain the current license number of the general contractor submitting the bid. All persons who violate this subsection shall be guilty of a Class C misdemeanor and shall for each offense for which he or she is convicted be punished, fined, or both, in accordance with Sections 13A-5-7 and 13A-5-12. (Acts 1935, No. 297, p. 721, §14; Code 1940, T. 46, §79; Acts 1959, No. 571, p. 1429, §1; Acts 1996, No. 96-640, p. 1013, §1; Act 2009-725, p. 2168, §1.)

All contractors shall bid and perform work in the name which appears on the official records of the State Licensing Board For General Contractors for the current license.

All bidders must include his or her current license number on the outside of the sealed bid envelope.
